

WHAT DOES LOOKOUT FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION? Rev. 01/21

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security Number, Government Issued Identification and address information, account balances and payment histories, credit history, credit scores and income and debt information on all applicants. When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Lookout Credit Union chooses to share; and whether you can limit this sharing.

What we do		
How does ISU Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured file areas and buildings.	
How does ISU Credit Union collect my personal information?	We collect your personal information, for example, when you open an account, deposit money, pay your bills, apply for a loan, use your debit or ATM card. We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
Why can't I limit all sharing?	Federal law gives you the right to limit only 1. Sharing for affiliates* everyday business purposes—information about your creditworthiness. 2. Affiliates* from using your information to market to you. 3. Sharing for non-affiliates** to market to you. State laws and individual companies may give you additional rights to limit sharing.	
Definitions		
*Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Lookout Credit Union does not have Affiliates.	
**Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.

Lookout Credit Union has no affiliate arrangements. Non-affiliates that we share with include insurance companies. Our joint marketing partners include insurance companies.
